In 2022, IJRS embarks on a 4-year journey as a legal research and advocacy institution. Every year, IJRS maintains a commitment to improving its performance in (1) encouraging policies related to an accountable criminal justice system and creating a corruption-free, fair, and efficient criminal justice system, (2) encouraging the implementation of good governance, especially in law enforcement institutions, (3) advocacy to achieve protection and fair treatment in the justice system, especially for vulnerable groups. In addition, IJRS also strives to ensure that organizations can be managed professionally and accountably.




With the pandemic's end, IJRS adjusted work mechanisms that combine work from home and work from the office alternately. The application of this mechanism aims to maximize the productivity and quality of work of researchers and staff in implementing the institution's programs.

The productivity and quality of IJRS work can be seen from the completion of research on policy reform in the government, including law enforcement institutions.

Some of the results of this research have been successfully embodied by IJRS in laws, regulations of the supreme court, regulations of the attorney general, as well as several guidelines in the Indonesian Prosecutor's Office. IJRS is also one of the teams formulating a roadmap for the issue of restorative justice in Indonesia. Based on the road map, IJRS also provides technical assistance to several Ministries or Institutions, one of which is the Indonesian Supreme Court Judicial Reform Team Office (JRTO), the Supreme Court – Judicial Commission liaison team, and the Indonesian Prosecutor's Office Access to Justice Working Group.

For advocacy and research work, IJRS oversees the preparation of the Criminal Code and judicial review of the Narcotics Law, as well as several studies regarding the application and opportunities for restorative justice in the criminal justice system in Indonesia, disparities in narcotics case decisions, legal needs survey for vulnerable groups, and others.


Overall, in 2022, IJRS successfully managed 12 programs in collaboration with 28 partners from civil society organizations, the government, as well as development partners. Therefore, IJRS has published several research and advocacy publications in the form of pocketbooks, booklets, guidelines, and various opinion articles in the media. IJRS publications are also displayed on various social media platforms, including Instagram, Twitter, YouTube, and TikTok, in the form of infographics, videos, reels, and others. Currently, IJRS social media, especially Instagram, has been followed by 3,835 followers, and the IJRS website has been accessed 91,225 times. Writings by IJRS researchers have also been published in mass media such as The Conversation. In addition, IJRS researchers often become resource persons in various public discussions, online media, podcasts, radio, and TV.



In addition to working with external partners, IJRS does not forget to also make institutional improvements and keep institutional management well-running. Completeness of internal rules is also being carried out, such as the issuance of the Decree of the Chairman of the IJRS Association No. 18/SK/IJRS/SK-Association/VII/2022 concerning Rules of the Code of Ethics and Behaviour of Institutional Personnel and Decree of the Chairman of the IJRS Association No. 21/SK/IJRS/SK-Association/XII/2022 concerning Regulations for the Prevention and Handling of Sexual Violence in the Workplace.

In addition, IJRS made revisions to other SOPs, including Financial and Administration System SOPs. This is done to strengthen institutional management and serve as a guide for all institution members in carrying out their daily work.

In realizing these achievements, IJRS did not walk alone. IJRS collaborates and gains support from various parties who also have the same vision to realize access to justice for the community. For this, we thank the CSO partners, government partners including the Indonesian Supreme



Court, the Attorney General's Office of the Republic of Indonesia, Bappenas, the Ministry of Law and Human Rights, in particular, the Law Development Agency, the Coordinating Ministry for Political, Legal and Security Affairs, the Judicial Commission, the Prosecutor's Commission, and the Indonesian Open Government Secretariat (OGI), as well as development partners, which over the past few years have supported the work of IJRS including AIPJ2, TAF, TIFA, UN Women, Rutgers, NCHR, IOM, IDRC-ALG, IDLO, and CRM-UNAIDS.

I would like to thank the Board of Trustees and the IJRS Executive Board for their hard work in maintaining a commitment to the vision of the institution in conducting research, advocacy, and educating the public so that the results of IJRS' work can be more easily understood by the public and become a reference for policymakers. Let's welcome 2023 with optimism and strong enthusiasm to continue to be consistent and committed to the vision and mission of the institution in encouraging reform in the field of law and justice.

years, challenges in law enforcement still constitute a crucial issue, where every law enforcement institution and all classes of society must pay attention to the implementation of TPKS Law and KUHP. Both legal frameworks will be very important because those frameworks will intersect with issues that frequently occur in the public lives. In addition, the proposal for revising the Narcotics Law serves as an issue that will be later addressed. This condition marks that the role of research in legal reform needs to be taken into the next level. Hence, IJRS hopes that the annual report of our society may illustrate the reflection of our work as a society thus far, hence it may be referred as inputs for external and internal parties in determining the next strategic steps.



Finally, on behalf of the Executive Body of IJRS, I would like to send my gratitude to supports from civil society organizations, universities, development partners, the government, and all parties that helped IJRS's works so far. May all IJRS's community be able to further improve and strengthen our performance, and our work products give benefits to all parties.

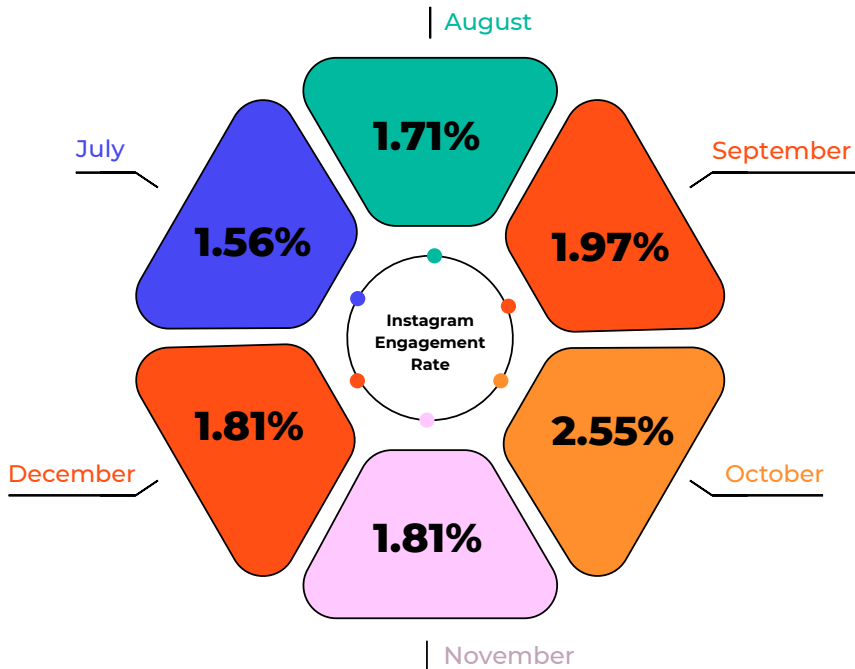

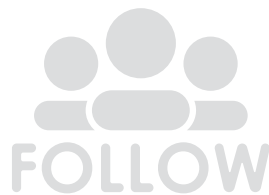

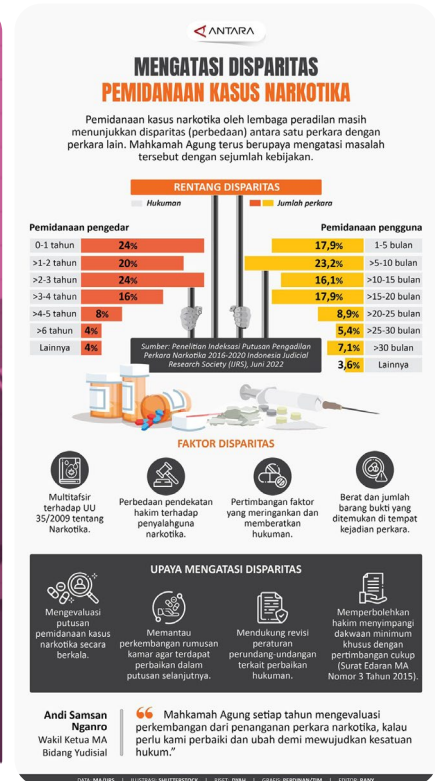
