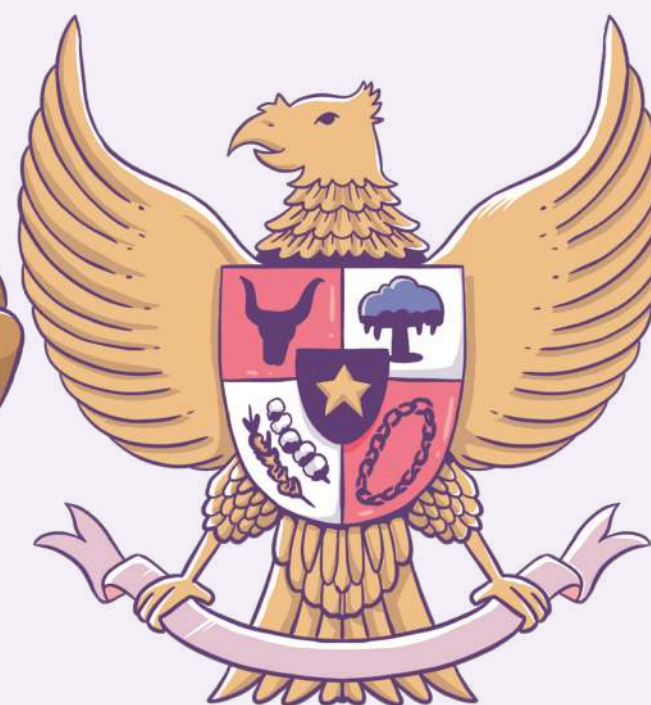




Justice for Women and Girls
