# ABOUT US

The Indonesia Judicial Research Society (IJRS) is a nongovernmental organization established in 2018 with a strong commitment to advancing legal and social reform in Indonesia through evidence-based research, advocacy, and public education. As an independent civil society organization, IJRS positions itself as both a connector and a solution-seeker, working collaboratively with government institutions, civil society coalitions, and communities to promote people-centered approaches to justice.

IJRS's work is grounded in four key areas. First, in the reform of the criminal justice system and legal policies, IJRS engages in rigorous research and advocacy to support improvements in areas such as narcotics law, restorative justice, capital punishment, and the development of Indonesia's Criminal Code and Criminal Procedural Code. Second, in the realm of gender equality, disability, and social inclusion (GEDSI), IJRS actively promotes legal and policy frameworks that address the rights and needs of vulnerable groups, including survivors of sexual violence, children at risk of early marriage, persons with disabilities, and other marginalized communities.

The third focus area is strengthening good governance within the legal system. IJRS believes that quality legal protection must be underpinned by capable and transparent institutions. It therefore supports reform initiatives in law enforcement, institutional planning, needs-based budgeting, and open government practices. Finally, IJRS is dedicated to increasing access to justice by conducting legal needs assessments, enhancing legal aid implementation, empowering communities, and monitoring the effectiveness of legal services and policy execution.

Through its core principle of Discovering Justice, IJRS is committed to continuously generating evidence, fostering inclusive collaboration, and ensuring that Indonesia's legal system evolves in ways that reflect the needs and realities of its people.

IJRS was registered as an Association Legal Entity through the Decree of the Minister of Law and Human Rights Number AHU-0014462.AH.01.07.Year 2018.

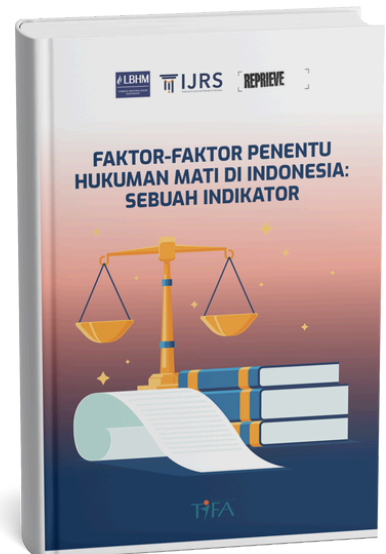
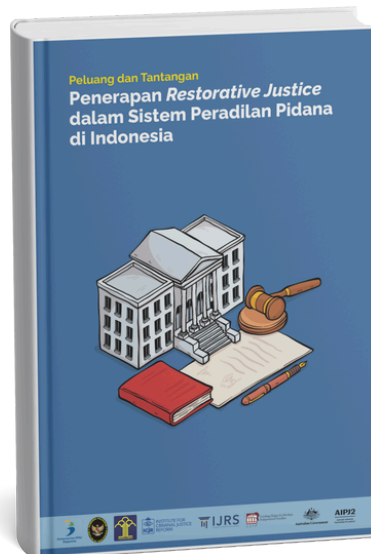
# OUR SCOPE OF WORK

# IJRS FROM TIME TO TIME

## 2021



IJRS with MaPPI FH UI and various development partners assisted the team under the Deputy Attorney General for General Crimes of the Indonesian Attorney General's Office to **draft and launch Guideline Number 1 of 2021 on Access to Justice for Women and Children when Handling Criminal Cases.**



IJRS, as a member of the Access to Justice Working Group of the Indonesian Attorney General's Office, assisted the drafting of **Guideline of the Prosecutor's Office on Handling Narcotics Offense and/or Narcotics Precursor Offense Cases and Guideline Number 18 of 2021 on Settlement of Handling of Narcotics Abuse Offense Cases through Rehabilitation by Using Restorative Justice Approach** as the Implementation of Dominus Litis Principle of Prosecutors.

## 2019



**The launching of the first Index of Access to Justice in Indonesia**, also the first in Asia, IJRS partnered with the National Development Planning Agency (Bappenas), Indonesian Roundtable Legal (ILR), and Yayasan Lembaga Bantuan Hukum Indonesia (YLBHI).

## 2020



IJRS, as a member of the Women and Children Working Group of the Indonesian Supreme Court, is committed to support the prevention of child marriage through the implementation of best interest of the child principles when adjudicating marriage dispensation petitions. This commitment is incorporated in the **Pocket Book of Guideline for Adjudicating Marriage Dispensation Cases that was validated by the Chief Justice of the Supreme Court.**



# IJRS FROM TIME TO TIME

## 2022



To ensure policy reform relating to narcotics offenses, IJRS conducted **research relating to the disparity in and handling of narcotics offense cases**. This research also establishes and provides several significant recommendations relating to narcotics policy, including the best course of action to be implemented in Indonesia and the urgency of having a sentencing guideline.



IJRS with HopeHelps Network jointly **created a discussion forum relating to the reality of sexual violence and the introduction of two newest legal frameworks** that may be inferred as monumental for handling sexual violence in Indonesia, namely **Regulation of the Minister of Education, Culture, Research and Technology No. 30 of 2021 on Prevention and Handling of Sexual Violence and Law No. 12 of 2022 on Sexual Violence Offenses**. This event was attended by the Ministry of Education, Culture, Research and Technology, Ministry of Women Empowerment and Child Protection, Kalis Mardiasih, Anya Canina, Academics from the Faculty of Law of Universitas Indonesia, and others.

## 2023



IJRS assisted the Indonesian Attorney General's Office to **launch the Indonesian Attorney General's Office Guideline Number 2 of 2023 on "Reasonable Accommodation and Accessible and Inclusive Case Handling for Persons with Disabilities in the Judicial Process"** as a commitment to strengthening access to justice for persons with disabilities.

## 2024



IJRS developed a research on **"Renewal of Criminal Procedure Law after the Enactment of the Criminal Code 2023"** which aims to identify adjustments that need to be made to the criminal procedure law after the enactment of the Criminal Code 2023.



IJRS was involved in the **2024 High-Level Forum on Multi-Stakeholder Partnerships (2024 HLF MSP)** event held by Bappenas. IJRS had the opportunity to hold 2 (two) side events, namely "Innovative Budgeting for Justice: The Comprehensive Cost of Crime Approach" and "Innovative Financing to Accelerating SDGs 16 In Indonesia".

## Capacity Building

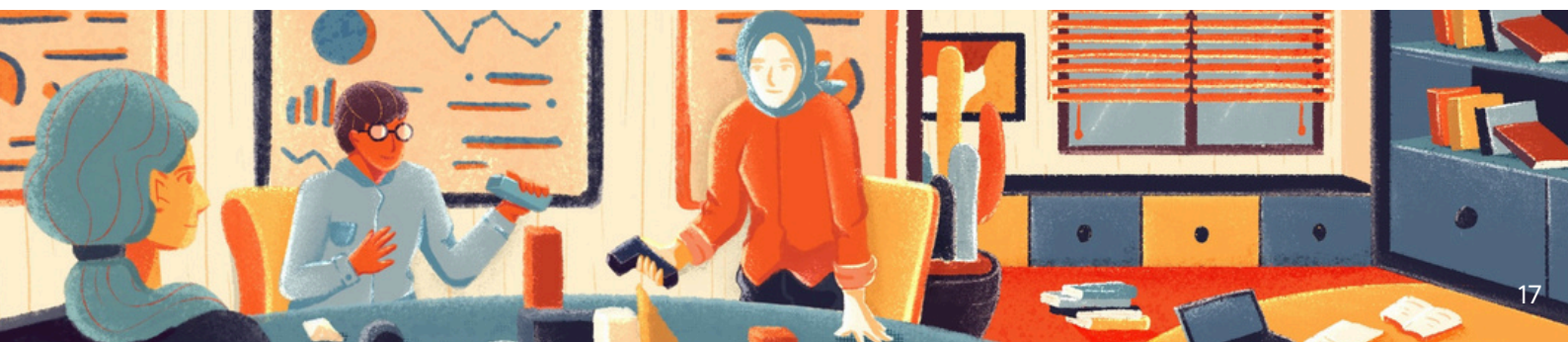

**Katahukum.id** aims to:

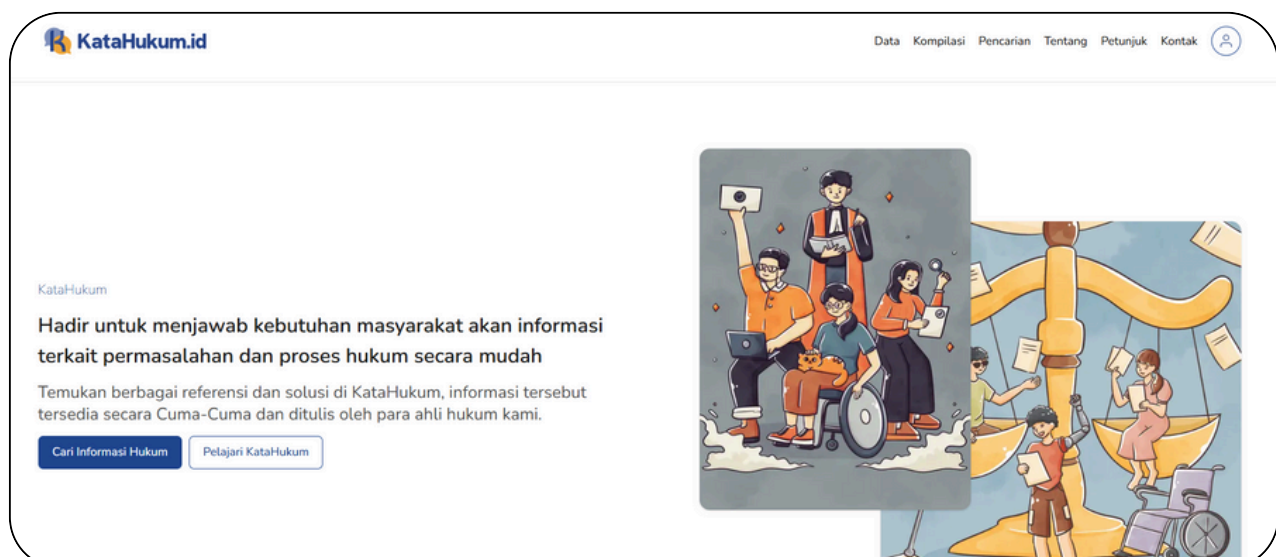
- As a one-stop platform for obtaining legal information that can be accessed anytime anywhere by anyone.

in the form of signatures at [change.org](https://change.org), this result has far exceeded the initial campaign target of 1,000 signatures.



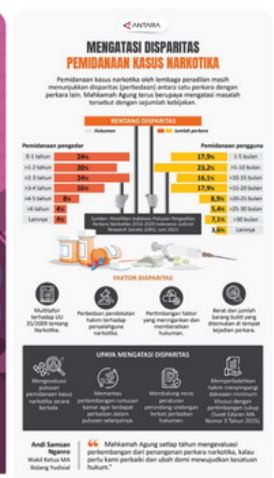
